Householder Application - Re-location and alterations to 3 bay cart lodge approved under application DC/21/05756 (following demolition of 3no.existing outbuildings to allow for the erection of cart lodge) - Hill House Silver Hill Hintlesham Ipswich Suffolk IP8 3NJ

Councillors discussed the planning application.

The Parish Council had No Objection to this planning item.

DC/23/02443

Full Planning Application - Erection of 3No two-storey dwellings and 1No single-storey dwellings, ancillary outbuildings and new vehicular access (revised scheme previously approved under DC/20/00351). Land Between Belfry Cottage And Pear Tree Cottage, North Of George Street, Hintlesham, Ipswich Suffolk IP8 3NH

Councillors discussed the planning application. The Parish Council (PC) had rejected the previous proposal under DC/20/00351 as it was considered to be Backland Development, and this is a policy that the PC does not support. However, with the removal of the rear single story dwelling the PC feels this is more in keeping with the existing linear character of George Street.

Also, as far as we can tell, the protection afforded by Policy CN03 (Visual Amenity Land) is not provided by its succeeding Policy LP28 (Open space within settlements)

However, the PC is still has concerns regarding the speed and volume of traffic using the A1071, concerns shared by both residents and the Police, and feel that this development will only exacerbate these matters. The Parish Council had No Objection to this planning item.
